



- ACRM members engage in the communities and have facilities in 20 counties across the state of Alabama.

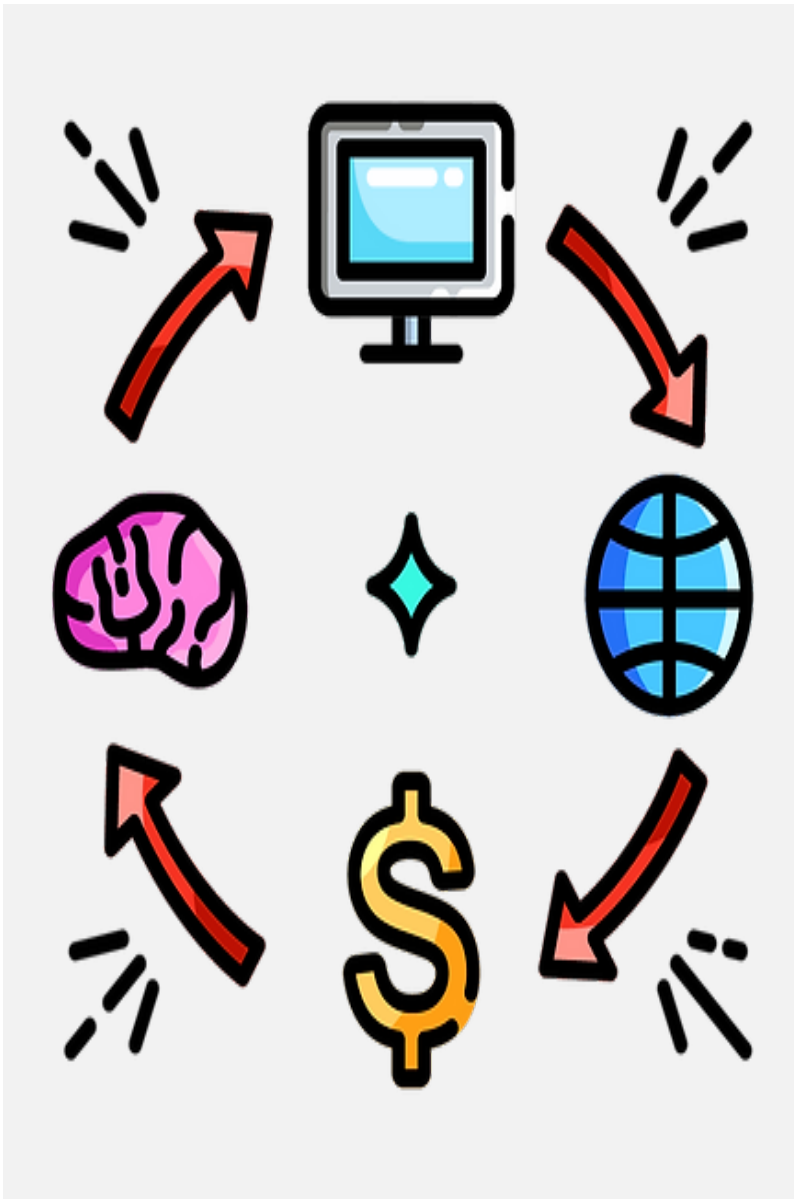

- ACRM successfully passed a consumer protection bill scheduling Kratom via the Alabama legislature in 2016.
- ACRM successfully worked with the Alabama Department of Health to protect consumers from the unregulated supplement Tianeptine in 2020.
- ACRM successfully passed consumer protection laws scheduling Tianeptine and Phenibut via the Alabama legislature in 2021. 10
